### Who Needs GST Registration?

Beforeyoujumpintopaperwork, checkifyoufallunder GST eligibility:

- Businesses with annual turnover above:
  - o ₹40 lakhs (goods)
  - ₹20 lakhs (services)
- Interstate suppliers of goods/services
- E-commerce operators & sellers on e-marketplaces
- Casual taxable persons
- Non-resident taxable persons
- Input Service Distributors (ISD)
- Any business mandated by GST law

#### **Special Category States under GST**

Arunachal Pradesh, Assam, Jammu & Kashmir, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura, Himachal Pradesh, and Uttarakhand.(Goods - 20 lakhs, Service- 10 lakhs)

### **Common Mistakes to Avoid in GST Registration**

Even small errors can delay your approval. Watch out for these:

- X Wrong PAN selection using individual PAN instead of business PAN.
- X Mismatch in details name differences between PAN, Aadhaar, and business registration.
- X Invalid address proof expired electricity bill or incomplete rental agreement.
- X Inactive phone/email OTPs failing because contact details aren't updated.
- X Skipping DSC (Digital Signature Certificate) mandatory for companies/LLPs.
- X Poor document scans unclear images get rejected.
- X Multiple applications filing again while one is pending creates confusion.

Avoid these slip-ups to save weeks of back-and-forth with GST officials.



## **Documents Required for GST Registration**

ltem	Purpose	Tip to Get It Right
PAN Card (Business/Individual)	Unique identification for tax registration	Make sure you use the business PAN if you're registering a company/firm.
Aadhaar Card (Promoter/Owner)	Identity verification of applicant	Details should match with PAN and phone/email should be active.
Address Proof of Business (Electricity Bill / Rent Agreement / Property Tax Receipt)	Proof of principal place of business	Documents should be recent and clearly scanned.
	To link GST with your bank	Account name should match business/legal entity name.
Business Incorporation Certificate / Partnership Deed / LLP Agreement	Proof of business constitution	Upload latest, government-issued copy.
Photograph of Owner/Authorized Signatory Digital Signature	Personal identification	Recent, clear passport-size photo.
Certificate (DSC) (For Companies/LLPs)	Mandatory for online filing and verification	Ensure DSC is active and installed properly.
Active Email & Mobile Number	To receive OTPs and GST notifications	Use official communication details, not personal ones.
